## Scope of this privacy policy

## Our use of your Data

- 5. For the purposes of the General Data Protection Regulations J P Chick & Partners Limited is the "data processor" of client data.

We will retain any Data you submit to us for 4 months, if after 4 months, you do not enter into a business contract with us your personal data and associated information will be deleted in its entirety. If you do however, enter into a business contract with us for our services, in which case your data will be kept within the project file for 18 years (Professional Indemnity Insurance purposes).
